Keynote Speaker

SPECIAL CONFERENCE ISSUE

Kate Butler will have many roles at MHSLA's Educational Conference "Renaissance "86". She will deliver the keynote address entitled "It's a Jungle Out There!" Later, she will conduct a workshop on "Leading Others to Improved Performance: The Coach Approach". Finally, she will coordinate the conference wrap-up to make it a goal-setting and accountability session.

Ms. Butler is widely known and appreciated for her humorous and practical approaches to problem solving. She holds a B.S. in communications from Ithaca College, New York, and is on the threshold of a master's degree in management from Aquinas College, Grand Rapids. She is executive director of american humanagement association (also known as aha!, also not capitalized), which is a consulting and training firm specializing in identifying organizational practices, systems, and norms which inhibit human commitment and productivity. Training sessions are more appropriately called 'learning sessions'.

Ms. Butler describes 'aha!' as the "sound of discovery". "Humanagement" is the art of leading other with full regard for race, creed, gender and national origin. A "humanager" recognizes and understands the cultural differences between "him/rself" (another Butler-invented word) and the individual employee and directs through these differences.

The need for such leadership was created by three major changes in today's workplace. In the modern workforce, white males are in the minority. Half of the workforce is under age 36 and have values which frequently conflict with those of the previous generation. Finally, there is a pervasive shift from an industrial to an information society.

In the conference workshop, participants will learn several things: to deal with subordinates' behaviors (not 'attitudes'), handle performance appraisals without shedding blood or tears, and recognize that just because some-one is different doesn't make him/rself wrong.

The conference wrap-up will help participants implement changes by using what they've learned. Blueprints for individual action will be devised. What discoveries (aha!) will we have!



MHSLA COMMITTEES FOR 1986-1987

The MHSLA committees are forming for this coming year, which promises to be a very productive one. Please read the following descriptions of the MHSLA committees and indicate your interests by checking the boxes below. Just fold this page and mail it to return it!

ARCHIVES - will be maintaining and soliciting the records of the association both to preserve its records and so that new officers can learn from our past experiences. The committee will also be collecting copies of policies and procedures, standard forms for ILL, photocopy and computer search requests, and samples of library guides from MHSLA members. These samples will be placed in expandable pamphlet files and circulated to members who are updating or revising these materials for their own libraries. 1985-1986 chair: Helen Howley Steele.

BYLAWS - studies the organization's bylaws to ensure that they meet the present needs and safeguard the integrity of MHSLA. Bylaws must be changed nearly every year to add new committees, clarify roles, change fiscal policies, etc. 1985-1986 chair: Hildegard Joseph.

EDUCATION - is in charge of identifying and meeting the educational needs of the membership based on the post-conference evaluation and the committee's perception of needs. The committee then identifies, recruits, and manages arrangements for all speakers and workshop leaders for the annual conference and arranges for MLA CE credits. 1985-1986 chair: Bonnie Swegles.

GRANTS (Ad Hoc) - this is a new committee, which will probably be writing a grant to get telefacsimile machines and have the initial telephone costs underwritten for any interested medical libraries in the state of Michigan. Once this is successful, the committee may undertake other grants or assist libraries in writing NLM collection or consortium development grants.

INTERLIBRARY LOAN - this will be a big year for this committee, which will be working to bring our state up onto DOCLINE. Members will be fielding questions and giving advice as they themselves learn about DOCLINE and its ramifications. This committee works closely with the Union List committee. 1985-1986: Doris Blauet.

LEGISLATION - identifies and responds to legislative issues which may affect medical libraries. This committee also informs the membership about these issues, acts as the memberships voice at library legislation days, and orchestrates the membership's response to legislation. 1985-1986 chair: Betty Gabhardt.

LOCAL ARRANGEMENTS, 1987 CONFERENCE - will be dealing with accomodations, registration, speakers, audiovisuals, hospitality, publicity, printing, and exhibits for the 1987 conference at the Hilton in Kalamazoo. The chair for this committee is Marge Kars.

NOMINATING - names the candidates for MHSLA offices and submits the slate to the membership. 1985-1986 chair: Pat Wolfgram.

PUBLICATIONS - is responsible for many things. First is the updating and maintaining of both the mailing and membership lists of MHSLA, which were computerized last year. Second is the creation of the annual membership directory from the membership database. Thanks to microcomputers, none of this should be painful or difficult! 1985-1986 chair: Stephanie John.

SURVEY (Ad Hoc) - a new committee, which will be designing a confidential and detailed survey of the hospital libraries in Michigan. Questions will cover staffing, salaries, collections, budgets, and other characteristics of the library and its institution. MHSLA expects that its members will be able to use the results to justify staffing, salary, and budget increases.

TECHNOLOGY - will be making recommendations to MHSLA concerning electronic mail, library software, CD-ROM, telefacsimile and so forth. This committee will also contribute a column to the quarterly MHSLA News and may hold a session at the annual meeting to update the membership on the latest technology. 1985-1986 chair: Tom Van Dam.

UNION LIST - will be updating the Michigan Health Sciences Union List of Serials and its directory. This committee will also be considering how to deal with entering information into the directory about participants who use and accept ILL requests by fax and electronic mail, and will be creating a single-sheet 'ILL policies at a glance' card. 1985-1986 chair: Barbara Kormelink.

Executive Board Decisions

At its last meeting in September, the MHSLA executive board decided to establish two new committees: grants and survey. The grants committee will be working on a grant to fund telefacsimile equipment for all interested medical libraries in the state of Michigan, together with enough funds to reimburse libraries for telephone costs for at least a year. The committee already has two members from the board and the board is seeking more people interested in either telefax or gaining grants writing experience.

The second committee to be established is the survey committee, which will be studying the facilities, staff and services of hospital libraries in Michigan. The board feels that national and regional surveys have been too general to meet our needs, expecially if MHSLA plans to write grants, for grants usually require detailed background information. This survey would include information on number of staff, staff salaries and benefits, sizes and currency of collections, budgets, space and other physical resources, population served, library policies, etc. (The survey committee will be soliciting the membership for other areas that the survey should cover.) The survey would be carefully designed to be quick to answer and easy to compile. It would also be strictly confidential, with responses treated like election ballots. Finally, when the survey is collated, all responses would be grouped into ranges so that individual institutions could not be identified. The board is also seeking volunteers for this committee.

Next Board Meeting

The November MHSLA board meeting will be held on Wednesday, November 5th at 10 a.m. in Kalamazoo at the Hilton. This will be a joint board meeting at which both the old and new boards will confer to establish goals and timetables for the coming year. (The board meeting will be followed by the Conference Planning committee meeting at 1:30 p.m..) All MHSLA members are invited to the board meetings. Please contact Stephanie John or Marge Kars for an agenda and a map.
