Message from the President Carole Gilbert, Providence Hospital

In my new role as a member of the MLA Board of Directors, I have begun to get newsletters from Sections and Chapters all over the country. It is interesting to read what is going on and to learn what folks are thinking in other parts of the country.

From Pennsylvania comes a call for a "Who Ya Gonna Call Emergency Network." This would be a "network of libraries who are both willing and able to provide 11th-hour-plus-assistance" ... i.e. after 4:30 on Friday (or any other evening) and on weekends. If libraries are to make a contribution to quality patient care and clinical decision making, it is vital that they be able to provide information when it is needed. Chris Balonis (Doylestown Hospital Library) maintains that excuses based on 9 to 5

weekday staffing only serve to erode confidence in the library as an important partner in the quality of healthcare services and medical care decision making. A creative idea ...

one which those of us who are able should consider.

Carol Burns, Southern Chapter Chair, comments on MLA's educational policy, Platform for Change. The Platform calls upon us to take immediate action to develop the skills and knowledge required for successful performance in our rapidly changing information environment. She points out that chapters (and state and local organizations) are committed to the professional development of their members. But ONLY YOU can make it happen. You must take advantage of every learning opportunity; you must help your colleagues with their professional development needs, and you must allow them to help you with yours.

MHSLA Board Meeting

The MHSLA Executive Board met on April 1 at Frankenmuth.

Treasurer Peggy Zorn reports a current balance of \$44,176. She reminded the Board that if the organization's income exceeds \$25,000 in a year, tax forms would have to be filed.

The Education Committee presented a calendar of events for the 1993 Educational Conference. Plans for a Support Staff workshop to be held on September 24th were discussed. The projected program will include a medical terminology seminar and a workshop on humor or laughter.

The Education Committee also requested that the Board reexamine the reimbursement offered to speakers who are MHSLA members.

The Local Arrangements Committee discussed special events, memorabilia, and estimated accommodations pricing.

Based on the estimates, the Board set the 1993 conference fees at \$135 for the full conference including a CE course, \$90 for the two-day meeting (including the special event), and \$50 for a single conference day. CE course registration will be \$85, and additional special events tickets will be available for \$20.

The 1993 conference will be the 20th hosted by MHSLA. In commemoration of this special anniversary, archivist Bill Nelton and Marge Kars will be publishing "Conference Proceedings" and are developing other materials to highlight our history.

The Board also voted to invite our past members to attend the conference to share our anniversary. Past members may attend Wednesday's meetings and special event without charge and will be recognized at the Business meeting.

This year MHSLA will again sponsor a member who has not previously attended our Educational Conference. The sponsorship will include three days' conference fees, hotel room, special event, and mileage. Qualified members should contact Melba Moss, Education Committee Chair (Port Huron Hospital, 313/989-5000 ext. 2370), for an application.

We will also sponsor a library student from each of the state's masters' programs, at

University of Michigan and Wayne State University. The students will be requested to share their experiences with their colleagues and to write a brief report for the MHS LA News. The scholarships will include three days' conference fees and hotel rooms. Members from the Ann Arbor/ Detroit area who are willing to share a ride with a student are requested to contact Melba Moss so their names and phone numbers can be passed on when the scholarships are awarded.

Document Delivery Committee chair Barbara Kormelink reported that statistics for the annual ILL report were still coming in. (The report is included later in this newsletter. -- ed.) In addition, the committee urges members to update their routing tables. The committee is considering developing a survey to find out who among our members are charging for interlibrary loans, and what amount they charge.

The Bylaws committee, in conjunction with the Publications Committee, has produced the 1992 Bylaws revision, which will be included in the 1993 Membership Directory.

The Research Committee continues to work with the recently completed "Mediated Literature Searches" project. The material will be presented at an MLA Poster Session, as an MLA Contributed Paper, and at a Poster Session sponsored by the Kalamazoo Nursing Research Association.

The Publications committee is hard at work on the 1993 Membership Directory.

The next Board meeting will take place on June 1 at Providence Hospital. Contact MHS LA Secretary Mary Griswold, Bronson Hospital, for details.

ERHSLA

ERHSLA's first meeting was held March 9 in Frankenmuth at the Bavarian Inn Lodge. The members voted to invite MHS LA to meet at the Bavarian Inn Lodge from Tuesday, September 27 to Thursday, September 29, 1994. Local arrangements committee chair will be Stephanie John. Other committee chairs volunteered. The next ERHSLA meeting will be July 1, 1993 at the Edison Inn in Port Huron.

NMHS LG

The Library staff at Munson Medical Center welcomed Janette Ransom-Bergstrom to their staff a few weeks ago. Janette works 20 hours a week as a Staff Librarian. Her identical twin also works at Munson, so there's been a lot of confusion!

Janette has a Master's Degree in Library Science from Western Michigan University and worked as a reference librarian at Lansing Community College while her husband was in law school. She more recently served as law librarian for the U.S. Court of Appeals in Grand Rapids before moving back to Traverse City where her husband works with Legal Services. Janette has joined MHS LA so the Northern Michigan Group now sports six members!!

Grand Traverse Community Hospital has become a subsidiary of Munson Medical Center. It previously was part of the Sisters of Mercy hospital system. Munson's Library now serves staff at Paul Oliver Memorial Hospital, Kalkaska Memorial Health Center, Leelanau Memorial Hospital and its new acquisition, Traverse City Community Hospital.

Munson library staff recently attended the GAC workshop in Lansing sponsored by MLC. They just became a selective OCLC user through ROC LSCA monies.

A merger in the Lansing area involves Ingham Medical Center and Lansing General Hospital. These institutions are now known as Michigan Affiliated Health Systems, Inc., Ingham Campus and Lansing General Campus.

Also in the Lansing area, Bill Nelton reports that the CALNET ROC is developing a union catalog on CD-ROM. The resulting database can be used as a local catalog as well as a locator for regional holdings. MLC is working with the ROC on the project.

The Western Michigan group has been pretty busy with conference planning. They did take time out for an "NLM Update" at a February meeting and are planning a workshop in "Producing professional-looking documents with your desktop computer" for a summer meeting in Muskegon. Support Staff: A Library's Foundation

On March 25th I attended a Michigan Library Association conference in Ann Arbor for library support staff. While I appreciated the usual advantages of attending such a conference -- conversation and collegiality among paraprofessionals, attending workshops particular to my needs/interests, and a great lunch -- I especially appreciated listening to remarks during a closing session given by two professional librarians and one paraprofessional.

The closing session of the conference was called, "Whose Job Is It? Defining the Role of Support Staff in the Library."

I'd like to share a set of the remarks that were made during that session even though they aren't all medical-library-specific.

*Margaret Auer, Dean of Libraries,
University of Detroit- Mercy:*

"The fate of all working librarians is intertwined. Professional librarians are depending on their support staff more and more while support staff have been pressed to perform more professional tasks/ responsibilities. Many evening and weekend hours are staffed by support staff without the assistance of professionals."

"The support staff take on many roles, one of which is the creating of the public relations image for the library." By way of example, Auer explained that most often it's support staff who "man" the circulation desk and whoever is at the circ desk is the visible image of the library.

Auer said that support staff should have a role in decision making and policy; should be involved in planning the organization of the library as well. Support staff need to be called on during the interviewing process for a new job/position.

Finally, Auer explained that support staff need to be empowered in their positions and that professional librarians should welcome teamwork from their support staff; and that morale and just compensation for what support staff do should be maintained as well.

*Linda Sickles, Library Director
Orion Township Library:*

Probably two-thirds of the workforce in libraries is now support staff. And support staff are the underpinnings that enable the library to function. By definition, support staff 'bear the weight and give support' to the library."

Despite this, Sickles said that the work of the support staff can be taken for granted or is often unnoticed.

Sickles said that professionals and support staff "must build a team approach to deliver services and that all staff need to be involved in decision making." It's the support staff, Sickles remarked, that have to live with the decisions and if the support staff isn't happy or empowered it will show and affect the whole system.

Support staff, Sickles continued, have technological expertise, sophisticated roles, and now come with two or four year

degrees from many other fields. "Support staffs' hands touch every library function and without their help the library won't succeed."

"Willingness to learn makes support staff a valuable employee. Make your interest in workshops and conferences known to your manager."

The paraprofessional speaker communicated some valuable advice for the support staff.

Betty Ramey,
Library Tech II,
Oakland County Reference Library:

Betty gave the following tips:

- ◆ Get organized and stay organized; keep an active 'to do' list;
- ◆ Take well deserved breaks; you work more efficiently if you do;
- ◆ Establish priorities;
- ◆ Whatever you do, do it professionally. "You don't have to have an MLS degree to do your work professionally. Have standards and ethics about what you do. Setting goals and 'networking' should be important to our daily work as well."

Sometimes when I feel that my role as a library paraprofessional is not always clearly defined or that some of my duties are not important I will remind myself of Auer's, Ramey's, and Sickles' thoughts and words.

MHSLA 20th Annual Educational Conference
October 12 - 14, 1993
Muskegon, Michigan

In keeping with this year's theme, *Empowerment through Enlightenment*, the conference will feature an all-day CE Course on "Power and Influence" presented by Elizabeth Poage Baxter, M.A., of the University of Michigan. The second CE course scheduled for Tuesday, October 12, instructed by Steve Ehmry of the Michigan Hospital Association is "Effective Budgeting: How to put the pieces into place."

Wednesday's calendar includes a keynote address by Elizabeth Poage Baxter, the annual Business Meeting, and afternoon workshops on Medical Terminology and CD-ROM. Wednesday's program also includes "lunch on your own" with enough free time to allow shopping and sightseeing.

On Thursday, workshops covering laughter, reference resources, and internet use are planned. Later, discussion groups on technology and one-person libraries, mentoring, credentialing, liability issues, establishing credibility with one's administrator, and the pros and cons of MHSLA pursuing chapter status in MLA will round out the program, which will conclude with members' contributed papers.

The Local Arrangements Committee has lined up two "special events" this year. To entertain those who will arrive Tuesday but are not attending the Board Dinner, a private tour of the submarine *U.S.S. Silversides* has been arranged. On Wednesday, all will be entertained by a Cabaret performance to be presented at the Holiday Inn - Muskegon Harbor.

A preregistration brochure describing the program is now going to press. The brochure and other publications relating to this year's conference will feature a drawing of Muskegon's South Pier Light. The lighthouse is one of two at Pere Marquette park on the Lake Michigan shoreline, and has "enlightened" the Muskegon waterway since 1903. Muskegon artist Merle Proctor has allowed MHSLA to adapt her drawing of the lighthouse for our publications. The assistance of Jeff Ek of Ferris State University's Media Productions department has been invaluable in this year's designwork.

To aid those looking for conference roommates, the Publications Committee has agreed to include a "Roommate Wanted" listing in the Summer MHSLA Bulletin.
