President's Column

As Michigan hospitals enter the second quarter of 1999, they continue to experience severe revenue declines in Medicare and Medicaid reimbursements due to the Balanced Budget Act of 1997, sharp increases in prescription drug cost, and the impact of managed care reimbursement structures. As a result staff reductions have been announced at several large hospital and healthcare systems. Since library staff has no direct patient care responsibilities, they are often very vulnerable when their human resources department conducts a job audit and classification.

With foresight, planning, good written and verbal communication skills, and understanding, [a job audit and classification] can serve as a platform to educate executives and human resource directors the unique skills of the library staff and how they fit into the organization structure.

Preparation and planning are the first key elements to a positive outcome for job audits and classification study. Begin to keep informal logs of tasks and assignments for three or four weeks during each quarter of your fiscal year. Maintain accurate organization charts and job descriptions for your organization. Gather library job descriptions from public, academic, special, and hospital libraries to compare tasks, responsibility levels, education requirements, and language.

Be ready to provide a clear, concise written description of the tasks and responsibilities for each library classification. If there is an opportunity to meet with the auditors, acknowledge them as professionals doing their job, not as adversaries. During an audit

interview, be able to discuss decisionmaking and supervision responsibilities, level of authority, internal and external organization policies and procedures that regulate the library tasks, education and experience required to provide library services, budgets, equipment, facilities, and technology, as well as the working environment, physical effort, and contacts involved with providing library services.

A well executed strategy for a classification study and job audit in the library can demonstrate the education skills, and talents necessary to operate a dynamic library that contributes to the bottom line of the organization.

Lois Ann Colaianni

Lois Ann Colaianni, Associate Director for Library Operations at the National Library of Medicine since 1984, retired in December 1998.

During her tenure at NLM, basic services and flow of medical information to the use community was improved. Ms. Colaianni also improved the working environment of the staff at NLM. Programs to expand preservation were put into place and an NIH-chartered committee to advise NLM on the selection of literature to be indexed was established under her direction. Many other improvements to MEDLINE were done under her direction.

Sherrilynne Fuller stated that she would be remembered as "superb role model, mentor and valued friend to hundreds of health sciences librarians in the United States and the world."

Tony McSean of the British Medical Library Association called Ms. Colaianni "the most respected figure in the world of health librarianship..." and characterized her as "an incomparably dynamic and reliable collaborator."
