HRPP Immigration/Visa Employment Policy

Beth Krueger gave a presentation on the new Human Resource Policy and Procedure, HRPP 08:01. This updated policy clarifies how to handle employment visas for full-time continuing or temporary positions. She gave a handout regarding this policy to everyone present, and asked it be shared with their departments. She said if a college is hiring anyone who needs a visa to contact Warren Hills or herself as soon as possible in the process so they can begin to process the visa for the person they plan to hire.

Subcontracting of Skilled Trades Work

Financial Aid for Interships
