ethics, psychology, and health services. This minor will be a valuable complement to many programs of study at Ferris. This interdisciplinary minor is designed to expand your understanding of health and illness in societies. This approach will facilitate your ability to effectively analyze health and illness at a variety of levels.

The American Health Care system is one of the largest employers today. This is a valuable minor for students planning to enter any health-related occupations and/or professions. It also provides valuable background for students majoring in human and social service-related programs. Employers today expect personnel who have a broad-based educational background. This minor will enhance your employment potential. This minor is particularly relevant for those students interested in getting a well-rounded education in their preparation for a career in medicine, public health, or other health sciences.

What does it add to student education?

This minor provides a comprehensive education related to the study of human beings. A number of medical related fields (Nursing, medical schools, Pharmacy, Health Care Administration, Public Health and community Health, Physical Therapy) and schools encourages students to select classes on medical anthropology, medical sociology, medical geography, medical ethics, reproductive health as elective classes to get a well-rounded education related to the study of human beings from a holistic, global and interdisciplinary perspective.

Survey of students:

Currently, there are 10 students in the minor. They were asked these questions:

- 2. Would you recommend this minor to other students?
- 3. Has the minor helped you so far?
- 4. Is there any problems with the minor?

Two students answered the survey. They have very favorable opinion about the minor. Most of the students are in Allied Health programs and they are very happy with the value that the minor add to their studies. They did not report any problems with the minor and they recommend it to other students.

Future activities:

The advisory board will meet yearly and:

- 1. review the program goals and asses student learning
- 2. review the curriculum and make appropriate changes if needed
- 3. review new courses that may be included in the curriculum
- 4. survey students, faculty and alumni

Admission Requirements

This Health, Illness and Society minor is open to any student admitted to Ferris State and pursuing a baccalaureate degree. The minor is designed to complement any Ferris major program. Students should choose courses carefully to avoid excessive overlap with their major or second minor. Students may use only one-third of the credits in a minor that overlap with the student's major. For example: If a minor is 18 credits, 6 credits may be applied to the minor that are also used in the major. Students may apply 6 credit hours of overlap between minors.

Graduation Requirements

An academic minor may only be awarded upon completion of a baccalaureate degree at Ferris State. This minor requires a minimum of 18 credits with a minimum 2.0 grade average in these courses. Also, 50% of the credits for a minor must be taught by Ferris State University.
