### 3. Other Business

#### FastTrack form update

The chair shared that a vote count column has been added to the fast-track form so that committee members vote can be accurately represented. This change which takes effect immediately aligns the form with Form A.

#### Certificate requirement update

The current UCC policy requires a minimum of 6 credit hours for a certificate completion. The chair asked members to review certificate requirements from at least two higher education institutions and bring their findings to the next meeting.

#### Honors Experimental Courses

While it is true that experimental courses are not reviewed by UCC but are provided for information only, some members were concerned about the lack of clarity on the content of the courses. Other concerns include absence of program level faculty and administrator’s signature on Form A. These concerns were shared with the APAO.
