The committee last met on Wednesday, February 4 via Anymeeting.com to discuss CEs and scholarships.

Conference Schedule: The conference will be held Thursday, September 24 and Friday, September 25, 2015. The Conference at a Glance schedule has been updated to reflect the finalized speakers (see Appendix A). Text for the conference program is also ready to be sent to local arrangements.

CE Courses: The committee has confirmed all of our CE instructors as follows:

- <u>Community Engagement 101: The Art of Building Community Partnerships</u> by Deborah Charbonneau (WSU) for 4 CEs.
- Emerging Technologies for the Busy Librarian by Gabriel Rios (Indiana University School of Medicine) and Melissa DeSantis (University of Colorado Denver) for 4 CEs.
- <u>Chemicals, Drugs, and Genetics Oh My!: Searching PubMed and Beyond</u> Holly Burt (GMR) for 4
- <u>Instructional Design: Proven Principles and Practices for Librarians Who Teach</u> Joey Nicholson (New York University) for 4 CEs.

Scholarships: Andrea Kepsel is heading up scholarships this year. All scholarships have been translated from Word Documents into Google Forms to make the submission and review process easier for the committee and the applicants.

- **Student Scholarships:** Announcements will be going out this month with the application period from March 31 April 30, 2015. Two scholarships are available for students.
- **Member Scholarships**: The application period will be June 1 30, 2015. Two scholarships are also available for members: 1) new member scholarship who has never attended the conference and 2) member scholarship that covers either the cost of hotel OR conference registration.
- **Diane LeBar Conference Scholarship**: The committee has drafted a proposal for the criteria and language for the Diane LeBar scholarship and seeks approval from the Board (see Appendix B).

GMR Professional Development Award: Beth Layton, the new GMR Director, reached out to Stephanie Swanberg about applying for a Professional Development Award for the MHSLA conference through a member library. The award could be used to cover the cost of bringing in a CE course instructor. The committee would like the Board's thoughts on applying.

Appendix B: Diane LeBar Conference Scholarship - Proposal

Eligibility Criteria: Any current MHSLA member employed in a hospital library or equivalent.

Scholarship winners will be determined by lottery. The scholarship may cover the cost of registration, lodging, and mileage. Scholarship winner will be reimbursed following the conference up to \$500. Winner has the opportunity, but is not required, to contribute a column to the MHSLA newsletter or staff the registration table at the conference.
