 - Faculty for Concurrent Enrollment will be required to complete orientation and professional development to participate in concurrent enrollment teaching
 - All concurrent teachers must meet adjunct requirements to teach and they must teach the course as if it were a course taught at Ferris, including meeting hours and course requirements
 - First Concurrent Enrollment orientation on April 17
 - Transfer Center will relate guidelines and requirements to interested teachers, and will explain to those teachers when they do not meet requirements

- 30% of current students in concurrent enrollment come to Ferris no data to determine if the students would have come to Ferris anyway
- Programs will determine standards in concurrent enrollment courses; syllabi will come directly from departments
- Handbook will state clearly criteria for teaching the class. Every year an instructor will be required to submit a renewal application
- Proposal is for Concurrent Enrollment model to begin July 1.
- Premier instance of Dual Enrollment orientation in July
- Suggestion to have a representative from Transfer Center sit in on the Gen Ed Taskforce
