Our association is full of leaders like this, and I have been inspired and mentored by many of them.

I think that leadership, as we need it today, is about flexibility, creative thinking, persistence, collaboration, and courage.

Earlier this month, there was some very interesting discussion on the MHSLA listsery, and I would like to quote one of our members whose comments really germinated the topic of this column. policies are putting barriers between your information resources and the users, or that a practice is violating copyright laws. Leadership, then, may also require diplomacy, but with courage and knowledge.

Jennifer also commented that "things will change. I think it's important to stay focused on the mission. The mission is NOT preservation of libraries. It's connecting people with the information they need. If there's a new and better way to do this, we should be ready to adapt." I couldn't agree more. If we cling to the "place" of information, as inviting and comfortable as that may be, then we risk being more marginalized. We need to provide more leadership to our organizations and that may mean making friends in unlikely places and working together to help a new department or group get the information, the way they need it, to make their decisions.

As you hopefully are making arrangements to attend this year's annual conference in Novi, focusing on our leadership in medical education, I hope you'll consider these words by Dr. Robert Jarvik: "Leaders are visionaries with a poorly developed sense of fear and no concept of the odds against them. They make the impossible happen."

### Michigan Libraries for Life

Last year libraries across Michigan participated in a simple and effective campaign to educate patrons about organ, tissue, and eye donation and offer the opportunity to join the Michigan Organ Donor Registry. This effort was originally spearheaded in 2010 by the University of Michigan's Taubman Health Sciences Library, but has expanded to include libraries on several university campuses across the state; University of Michigan Ann Arbor, Dearborn, and Flint campuses, along with libraries at Eastern Michigan University, and Grand Valley State University. This collaborative effort resulted in registering 414 new organ donors, reaching over 1500 visitors with information on organ donation and registration information.\*



More than 95% of Americans support organ, tissue and eye donation. In Michigan, only 34% of adults have joined the Michigan Organ Donor Registry, far lower than the 43% average nationwide. That discrepancy is largely due to state residents not knowing how to properly sign up. Michigan Libraries for Life helps to address that informational need.

We are excited to bring this life-saving event back in 2012, expanding to include many more public and academic libraries. This year's 2-day drive will start on Tuesday, October 2nd and run through Wednesday, October 3rd. Participating libraries are welcome to join the effort

for as many hours as they are able to staff a registration table, from 2 hours to 2 days. Gift of Life Michigan will provide free in-person training for library representatives at their Ann Arbor headquarters. This training session is scheduled on Friday, August 24th from 11:00am-1:00pm and lunch will be generously provided by Gift of Life Michigan. We are also developing additional training materials for institutions that are unable to attend the in-person session.

The key to this program's success is the participation of organizations such as your library. We would like to extend a formal invitation to MHSLA libraries to join the Michigan Libraries for Life Organ Donor Registration Drive for 2012. ### Munson Healthcare Department of Library Services Restructures

The Department of Library Services, at Munson Healthcare in Traverse City, recently reorganized and expanded its scope of service. The department, now called Knowledge Management Services (KMS), continues to incorporate existing library services with a shift towards a formalized knowledge access and transfer service model.

Knowledge Management Services (KMS) leverage institutional intellectual assets in order to facilitate knowledge creation. Information is combined with the end user's ability and experience and is used to solve a problem or to create new knowledge.

Embarking on supporting KMS within Munson Healthcare demonstrates a proactive next level shift from traditional data mining, filtering, disseminating, organizing, packaging and pushing out of information, to a systematic approach of capturing and storing individual knowledge (tacit), as well as knowledge embedded in organizational practice (explicit). KMS also integrates the concept of "communities of practice", which leverages tacit knowledge by enabling direct interaction to engage groups in advancing a field of practice.

KMS integrates the same systematic analysis and process implementation utilized by librarians in a healthcare environment.

Knowledge Management embraces four guiding principles:

- 1. Knowledge Repositories Provide the ability to store both knowledge and information, including print, electronic and digital content.
- 2. Knowledge Access and Transfer Provides the ability to access, disseminate and transfer information.
- 3. Knowledge Environment Provides the ability to increase awareness on sharing knowledge embedded within the organization.
- 4. Managing Knowledge Recognizes the value of knowledge within the organization and creates/maintains a structured knowledge base to capture and create a knowledge exchange.

  The people structured KMS will implement a pilot program utilizing stakeholders from the following depart.

The newly structured KMS will implement a pilot program utilizing stakeholders from the following departments: Strategy and Planning, Decision Support, Management Engineering, Community Health and Library Services in order to formally launch this new initiative.

### Summary


The role of traditional hospital library services has changed due to the rapid expansion of human knowledge, the demand for information literacy and the complexity of managing a collection of dynamic print, electronic and digital resources and applications. Collectively, we are continuously challenged when locating, accessing and capturing knowledge in order to enhance organizational performance.

Currently at Munson, we have no framework in place to conceptually manage tacit or explicit knowledge. Work output in print, electronic or digital format, is fragmented and stored randomly within the organization. KMS overarching strategic Initiatives would:

- 1) Incorporate lean principles and move from a push methodology to a pull methodology by creating a structured knowledge repository.
- 2) Capture tacit and explicit knowledge to formulate access to a centralized exchange process.
- 3) Advance communities of practice.

KMS develops and sustains a systematic framework for obtaining, organizing and providing on demand access to internal information. Knowledge Management is strategically important for Munson to gain a competitive advantage, add value, decrease costs, improve customer satisfaction, improve patient safety and enhance overall patient care.




## New Library at MidMichigan Medical Center
