(1) identify a mechanism by which an academic unit can establish a

variance in evaluation procedure,

(2) develop a method or methods for streamlining the process of evaluation,

(3) edit the document as appropriate.

Any revisions or edits should be presented to the Academic Senate at the March meeting. Devlin supported. Motion failed.

Administrative Evaluation

14.1. Pomnichowski moved that the Senate request the University administration to provide the faculty/staff with the opportunity to participate in an administrative evaluation during the Spring Term. Ferdowsi supported. Motion carried.

ASG Finals Week Study Resolution

- 15.1. Pearson moved that the Senate endorse the ASG Resolution recommending the formation of a committee to study the advisability of adding a finals week to the academic calendar. Peterson supported.
- 15.2. Cook moved to postpone action until the next regular Senate meeting. Gillette supported. Motion carried.
