President Uniacke invited response to the Senate Task Force on University Planning Report. Peter Chesebrough introduced a memo concerning the Electrical/Electronics Department. Warren Klope suggested the university needs a common core data base.

New Business

Discussion of the Task Force plan, following the stated discussion order, continued.

Actions needed (cont.)

von der Osten discussed the rationale for combining colleges.

Wheeler moved to add "Maintain the College of Allied Health Sciences as its is" to section 13.1 and to strike all language concerning combining the College of Allied Health Sciences with the College of Pharmacy. Totten seconded. The amendment failed.

Totten moved to add "Combine the College of Education and the College of Allied Health Sciences to become the College of Allied Health Sciences and Education." Wheeler seconded. The amendment failed.

Hastings-Bishop moved to rewrite Section 13.2 to read "Keep the College of Education as a separate entity. Expand the role of the present College of Education. Change the name to the College of Education and Human Services to more accurately reflect its role and mission. This will allow the College of Education to maintain its identity in training of teachers and human services workers. Add the new initiative of a Center for Teaching, Learning, and Faculty Development (Administrative Plan, Nov. 1993, p. 33) to the new College of Education and Human Services. The college's faculty have historically served in this type of leadership role on campus and continue to be the leaders in new educational initiatives in the state." Kebler seconded. The amendment failed.

Keys moved to strike the sentence "Review the possible merging" from Section 13.3 and to strike Section 13.4 completely. Pomnichowski seconded. The amendment failed.

Hagstrom moved to change the wording of Section 13.5 to read "Industrial and Environmental Health Management should not be placed in the Department of Health Management but in the Department of Clinical Lab Science." Lewis seconded. Hagstrom withdrew her motion. Smith moved to lay this motion on the table for a short time to obtain necessary information. von der Osten seconded. The motion carried.

Pominchowski moved to delete "There has, however, been a clear lack of leadership in meeting these changing conditions" from Section 13.6. Nagel seconded. The amendment carried unanimously.

Saladin moved to strike the bold section in paragraph 1 of Section 13.5 and to add "The College is recommended to review the feasibility of combining departments with the possible reduction of one department head." Valas seconded. The amendment carried unanimously.

Patten moved for a short recess. Smith seconded. The motion carried.

Sytsma proposed to add "Ferris needs to improve its funding from sources other than tuition. Ferris must build a strategy that results in an improvement in the level of its general fund appropriations from the State of Michigan to a level commensurate with its equipment-intensive instructional mission. It must build a long-term plan that results in the improvement in the number and size of donations from alumni and industry and is effective in obtaining a higher level of grants and contracts from governments, industries and foundations to assist in supporting our instructional efforts" to Page 5 #6. von der Osten seconded. The amendment carried unanimously.

Keys moved to add "Increase the level of funding by the State of Michigan. Ferris should aggressively pursue a higher level of state funding in recognition of the costly nature of many of our programs" to Section 10.3. Dakkuri seconded. The amendment carried unanimously.

Bradt moved to strike from the third paragraph on Section 13.7, p. 47, the words "Restructure . . . interrelationships" and to add "The College of Technology is recommended to review the feasibility of combining departments with the possible reduction of one department head." A division of the house was called: 17 in favor, 0 opposed, 13 abstentions. The amendment carried.
