WHEREAS, the development of the Plan and the established review process have (1) disregarded the Senate's established curricular policies and procedures, (2) violated any semblance of collegial governance at the University, and (3) established an unreasonable timetable for Senate reaction;

RESOLVED, that, given these various constraints, the Academic Senate find it impossible either to provide an informed and intelligent response to the Plan or to endorse the Plan in its present form.
