**II. Call to Order**

President Key called the meeting to order at 9:20 a.m. at the Brown Bungalow Restaurant.

**III. New Business**

President Key explained that there are no Senators on the Academic Program Review Council who can chair the committee. It was moved by Senator Heidemann, supported by Senator Konrad that the Academic Senate hereby rescinds that portion of the motion, **5.14**, from the minutes of the March 15, 1995, Academic Senate meeting that stipulates that ***“the chair must be a senator.” (See Attachment A)***

**IV. Announcements**

**President Sederburg (Attachment B)** - President Sederburg addressed issues of importance to include NCA Assessment (April 21-22, 1998), Post Tenure Review, articulation agreements, new program implementation, marketing review and training, budgeting analysis, and the filling of key positions (the Senate will have four (4) members on the search for the Academic Affairs Vice President). He also stated that the University is approaching a 60% retention rate.

**Vice President Burcham (Attachment C)** - Briefed the Senate on applications to the University, offers of admission, and total numbers of students for Fall 1997. Also included in Dr. Burcham's presentation was

scholarship and financial aid information with an overall survey of 1995-96 highlights.

**Vice President Chartkoff** - Dr. Chartkoff was introduced to the Senators and made a brief presentation to the Senators regarding his background.

## V. Reports

### **University Curriculum Committee**

Senator Smith gave a brief report. See **Attachment D** for complete listing of recently passed proposals and proposals being currently worked on by the UCC. Senator Smith (outgoing chair) also presented Senator Valas with a small gift for attending every UCC meeting.

**Post Tenure Review Committee** - Greg Key, chair, informed the Senate that the committee had presented a draft document to the Dean's Council. **Attachment E** is the draft product that a sub-committee of the Dean's Council (Dr.'s Barnes, Mathison, and Cory) returned to the committee. Dr. Barnes explained that the document may not be appropriate for counselors and librarians. Also, a target date is needed. Many questions still need to be answered regarding this issue.

**Academic Program Review Council** - Dr. Doug Haneline presented the Senators with proposed changes (**Attachment F**) to the structure of the Council. The proposed changes will be presented to the Senate at their September 2, 1997, 10:00 am meeting. There are also three vacancies on the Council.
