The Nominating Committee would also like to suggest to the Committee on Bylaws that it consider changing the requirement that there be a representative from each area group nominated for the Nominating Committee. We suggest that eight names are too many to fill three positions and that a fair representation of the entire state could be achieved through some other method.

The Nominating Committee also suggests that the Board standardized the format for the biographical statement and the statement of aims requested from each of the candidates. This would enable a better comparison between candidates and would also give the candidate some guidance in preparing his statement.

If the suggested candidates are approved by the Board, the Nominating Committee will proceed with securing the consent to serve, the biographical statement, and the statement of aims from the candidates.

STATEMENT OF AIMS

It is important for us as health sciences librarians and as members of MHSLA to maintain and improve, where possible, cooperative efforts among ourselves and with other types of librarians. Such efforts include the production of a statewide union list of health sciences serials; participation in the Regions of Cooperation as developed by the State Library for interlibrary loans; and, providing assistance to underdeveloped libraries either as individuals or as a group. A high quality annual conference is also important because of the educational opportunities it offers and because of the professional contacts and exchanges of ideas that occur among and between the different types of health sciences librarians. As an organization we should refine our positions with the state to adequately represent our diverse membership and to meet the professional needs of the members. We also need to define our position as a regional group within the national scope of health sciences librarianship.
