# President's Memorandum to Faculty and Staff

Office of the President May 7, 2012

#### Commencement

This last Friday and Saturday we celebrated our graduating class of 2012. More than 1,300 of the 1,700 candidates for graduation took part in the ceremonies. For me, commencement is a high point of the academic year. It brings into sharp focus the difference a Ferris education makes in the lives and futures of our students.

At commencement I share stories of our students and their determination to succeed, in some cases overcoming major challenges. Included among our graduates this year are immigrants to our country, students who have overcome significant physical and medical challenges, graduates who have earned their degree as adult learners, and students who made a life-changing difference for others. While all of the stories are compelling, let me share one example.

Cory Smith is remarkable in that the small high school he attended did not have a tradition of graduates attending college. From a class of 48 only 2 continued to college. But his determination to pursue a college education is only one of the things that make him stand out. During the summer of 2008 he drove his girlfriend to Ann Arbor every Friday to get treatment for her leukemia. They married in 2011 and she is now completing her second year in Pharmacy at Ferris. Then last year his best friend, a fellow Ferris student, developed a medical condition that required a kidney transplant. Cory was tested and, after finding that he was a 99 percent match, donated a kidney to his friend. Graduating in Surveying Engineering, this fall he continues his education in the Master of Engineering program at Purdue.

One of the common characteristics in these extraordinary stories is that Ferris takes a personal interest, reaches out and helps these students. Thank you for making a difference. A total of 11 medals were earned with Marcus Vanpoppelen (Technical Drafting), Brad Edlund (Architectural Drafting), William Burtt (Diesel Equipment Technology) and John Bohnett (Graphic Communications) bringing home gold medals. The four gold medal recipients will move on to compete at the national level in Kansas City the week of June 23-28. Professors Joe Compton, Gary Gerber, Pat Klarecki, Paul Long, Gary Maike, Ramon Robinson and Dan Wanink provided volunteer assistance to their students in preparing for this event

### Oliver Evans Tribute

Last Saturday, Kendall College of Art and Design held an event celebrating the career of Kendall President Oliver Evans, who is retiring this July after 18 years with the college. It was a fitting recognition of the service that Oliver has given to Kendall, and especially his role in facilitating the merger between Kendall and Ferris.

The fall 2011 issue of *Ferris Magazine* featured an interview with Oliver in which he reflected upon his career with Kendall. When asked what people will think about when they think about the Oliver Evans presidency, he was typically modest. He said that he just hoped people think he "was the right person at this particular moment in the college's history." As someone who has a unique perspective on Kendall and the opportunities it provides its students, I can say that Oliver was absolutely the right person to take his college to the next level of its history.

Obviously, a major event during Oliver's presidency was the merger with Ferris. Oliver saw the complementary missions of Kendall College of Art and Design and Ferris State University. Historically, both institutions have valued the practical, real-world application of learning. By joining forces Kendall and Ferris created a partnership that draws upon that tradition and updated it for the 21<sup>st</sup> century. Our joint educational mission has been greatly strengthened by the merger, and for that Oliver deserves credit both for his vision and for the hard nuts and bolts work that went into making the merger into a successful partnership.

It has been my privilege to work with Oliver for the last nine years and to witness a real transformation of Kendall into a resource not only for Kendall students, but for the city of Grand

Rapids. Oliver will be missed, but the legacy of his leadership is a college with a strong vision for what it is and what it wants to be in the future.

## Former Federal Building Opening

Last Tuesday we held a "soft" opening for the former Grand Rapids Federal Building, which is now a part of Kendall College of Art and Design. Kendall's fast-growing enrollment has made extra space for the college a priority, and the renovated historic Federal Building is an amazing addition to our Grand Rapids campus.

Kendall President Oliver Evans, incoming Kendall President David Rosen, Grand Rapids Mayor George Heartwell and others offered remarks. The opening coincided with the annual Kendall student art exhibition, and the renovated building gallery space provided the perfect venue for the students' remarkable work.
