President's Memorandum to Faculty and Staff

HLC Accreditation

If you have been away from campus, welcome back from spring break.

There is very good news to report from the Higher Learning Commission. After sharing the draft HLC report with you in December, I expressed my concern to the Commission regarding the progress report they had requested on the relationship between Ferris State University and Kendall College of Art and Design. As I reported to you earlier, I felt their findings had been formulated on incomplete information and a misunderstanding of the strengths of our unique relationship. Recently the HLC's Institutional Actions Council reviewed my appeal together with the visiting team's draft report from their site visit last April. The Higher Learning Council has notified Ferris State University that we have received full accreditation for the next ten years without any additional follow up or progress reports. This places our University among the top tier of educational institutions with a clean review and full ten-year accreditation. Our next evaluation is scheduled in the 2020-21 academic year.

Many of the areas the HLC pointed to as university strengths were broad-based, including how the Ferris community is committed to our educational mission, appreciates our history, supports diversity, promotes a global perspective, and both works and plans in a collaborative fashion. Other areas of strength recognized in the report include our curriculum, finances and facilities, the relevance of our approach to learning, our library, and the support we supply to students and learning resources.

The HLC evaluators also identified areas that we should focus on and seek to improve. These include assessment, faculty scholarship, general education revision, graduate education, instructional technology, technology infrastructure, and our relationship with Kendall College of Art and Design.

Our University first began organizing and preparing for this review in 2007 and we have used this process to carefully examine and improve. I once again want to thank everyone who was involved in this process, including those who took leadership roles -

Combined with the enrollment growth we have experienced, the innovative programs we have launched and the new facilities we have dedicated, this validation by the HLC is yet another sign Ferris State University is a strong and vibrant institution that is succeeding through the teamwork of its people.

Health Insurance Information Forums

The rising costs of medical care and health insurance premiums are areas of concern for faculty and staff at our University.
