President's Memorandum to Faculty and Staff

Office of the President February 25, 2008

Last fall I convened three task forces to examine the tragedy that took place at Virginia Tech. These task forces were organized around broad areas of concern: security, communication during and after an emergency, and strategies for dealing with disturbed students. Our Emergency Situations Student Support Committee, Information Technology Communications Task Force and the Security Infrastructure Task Force did an excellent job of examining Virginia Tech's internal reviews, as well as the State of Virginia's "Mass Shootings at Virginia Tech" external review. In this process they considered hundreds of pages of documents in the context of Ferris State University.

I want to update you on our efforts to learn from this tragedy, and the planning we've done to prepare for unforeseeable events. We have worked hard to synthesize these materials, coordinate our efforts, and prioritize the adoption of recommendations from the task force reports.

Three things have become immediately apparent. First, much good work has been done on emergency preparedness at our University.

Second, emergency management cannot rest solely on work already completed or this reexamination in the context of Virginia Tech; it will have to be an ongoing effort to be successful. Third, as individuals it is important we develop our understanding of potential threats, be prepared ourselves, and know how we can assist our neighbors.

The following recommendations are either underway already, or will be implemented in the immediate future.

Recommendations that involve planning -

- 1) Emergency Response Plans will be kept up-to-date and their distribution coordinated.
- 2) Emergency Planning and Response at locations outside Big Rapids will be reviewed, evaluated, and updated.
- 3) Post-event communications and business continuity plans will be developed.
- 4) A Students of Concern Committee has already been established by to improve communication, collaboration and cooperation among the various offices that typically coordinate care and deal with disturbed and/or disturbing students. A Threat Assessment Team (TAT) is also being formed to determine if a specific student is a threat to themselves or others.

Recommendations involving education, training, and practice -

- 1) A comprehensive plan of drills and emergency response training to include all buildings and to be available to all campus employees and students will be developed and implemented.
- 2) Programs will be developed to educate students, faculty, and staff on depression and suicide, high risk situations, and disturbed/disruptive students in and out of the classroom. Programs will also be developed on FERPA, HIPAA and ADA regarding the sharing of information on disturbed students.
- 3) Student workshops will be developed on conflict management, resilience and problem solving.

Recommendations involving technical capabilities -

- 1) A grant-funded "City Watch" communications system that provides the capability to communicate with University employees and students via landline, cell phone, email, or text message has been purchased, should be installed before the end of the academic year and operational before fall semester begins
- 2) Classroom communications will be enabled by the installation of telephones in each room and instant messaging software in all teaching station computers. Further study will determine if classroom telephones should be a standard device, use Voice Over Internet Protocol (VOIP), or be some other Internet-enabled device.
- 3) The current blue light emergency assistance phone system will be upgraded and expanded to reflect campus traffic patterns.
- 4) Card readers are currently in residence hall doors. This system will be expanded to include 18 residence hall "front door" entrances for 24/7 access.
- 5) Current campus and building security systems will be evaluated.
- 6) A multi-year plan will be developed for the installation, maintenance, and replacement of the campus network.
- 7) The installation of additional electronic message boards in strategic, high-traffic locations will be studied.

These actions build upon emergency planning efforts already underway at the University. Beyond these fourteen action items, there are numerous other recommendations. To continue and coordinate the evaluation of our emergency preparedness and implementation of task force recommendations, I will create and chair a coordinating committee to work with the Emergency Management Team.
