acknowledge the significant investment of time and effort by their colleagues in reviewing and recommending these recipients.

### **Vice President for Academic Affairs Search**

Next year we will search for a Vice President for Academic Affairs. We need to begin this process by establishing the search committee before the end of this academic year. This committee will develop the position description and advertisement now so we will be prepared to begin the search immediately in the fall. This will provide additional time for reference and background checks of prospective candidates.

Each college will be represented by a faculty member on this search committee. Today I sent a message to each academic dean asking them to choose a faculty member for this committee from recommendations of their department chairs or department heads. If you are a faculty member interested in serving on this committee, I would encourage you to speak with your department head or chair. In addition I will ask the president of the faculty union and the chair of the academic senate to serve as members of this search committee. Other areas throughout Academic Affairs and our University will be represented on this committee. Before commencement I will share with you the membership of this very important committee.

In conversations with faculty across campus I have proposed designating our next Vice President for Academic Affairs as a Provost, a distinction that I believe appropriately reflects the centrality of academics to the mission of a learning-centered university. This proposal has been received with significant support and I would appreciate hearing from you on your thoughts regarding this.

### **State Budget Discussions**

Tuesday evening was the most disappointing session of the Michigan House I have experienced. House leadership produced a bill to balance the current year's state budget and did much of this on the back of higher education. Both the Governor's and Senate's budget plans had included a deferment of half the payment we would receive from the state in August. House action moved to defer the entire August payment. For Ferris State University this amount would be in excess of \$4.54 million. The intent would be to fund this in October, although the source for these monies, which would now total \$66.5 million for higher education, has not been identified.

Beyond this delayed payment, the House removed all funding increases received in this year's current higher education budgets. For Ferris this would mean a reduction of \$1.41 million or 2.8%. For some universities the proposed reductions are even worse, including a 5.7% reduction at Grand Valley and a cut of \$9.427 million at the University of

Michigan. It is truly unfortunate current House leadership does not support the position of our Governor, that higher education represents the future for Michigan.

At the same time it is very important to observe that the chances of this budget reduction plan being enacted are very small. In passing their budget reduction package the House linked it to the Governor's plan for replacement of the Single Business Tax, which is unlikely to be accepted.

We now have three different budget plans, from the Governor, the Senate, and the House. Next there should be a conference committee between Senate Republicans and House Democrats with representation from the Governor's office that seeks to resolve the significant differences among these approaches. We will work very, very hard to reverse the negative stance on higher education funding taken by the House. A compromise will be reached, but it now seems a certainty that this will occur with two months or less of the budget year remaining.

### **Commencement**

Commencement is just more than two weeks away. During each graduation ceremony I enjoy highlighting the efforts of one or two students whose success demonstrates extraordinary accomplishment. These stories help emphasize the human dimension of what our educational experience can be. This has been a week like few others in higher education history. Thank you for the support you are providing our students during this challenging time. I appreciate you, your assistance, and your support very much.
