Anatomy of a Plug-in 8:00am - 12:00pm (half-day) Lunch Not Included

The expanding arena of Internet software changes and evolves at a rapid pace. Driven by the growing need to meet user and market demands, software designs have been developed to incorporate a number of techniques to swiftly adapt to immediate needs in the real world. One successful approach, enabled by modern software development tools, techniques, and open standards, is the development of "plug-in" products and the underlying software infrastructure. In this hands-on workshop, we will examine the nature and development of plug-in technology, including a survey of today's popular titles and major market players. We'll take a brief look at the details of how they work, as well as the conceptual model at the foundation of their development, distribution, and installation. Part of the time will be devoted to the installation and configuration of common plug-ins, along with samples of their use. Ample time for questions and answers will be available, and active participation by attendees is highly encouraged.

Exploring Technology: Collaboration Between Library and Information Technologists 1:00pm - 5:00pm

Eastern Daylight Savings Time (half-day)

This half-day videoconference forum is planned to provide institutional teams of librarians and information technologists the opportunity to acquire knowledge and develop techniques designed to increase the effectiveness of collaborative efforts. The broad focus on partnering in the first part of the workshop, and the narrow focus on institutional priorities in the latter part will address the needs of a broad range of people, perspectives, and projects.

The workshop is designed to be highly interactive, with sharing among the full group, pairs of librarian/IT institutional teams, and reactor panels participating at the Grand Rapids host site and the four remote sites connected by videoconferencing technology. The forum will also include targeted individual presentations.

Specific goals of the workshop are:

- To bring together librarians and information technologists for cooperative partnership activities,
- To identify common factors that motivate professionals into solution-orientated modes in their institutions,
- To share ideas and creative models of collaboration,
- To utilize these ideas and skills in practical ways.

The program will include an overview of cultural systems ideology, an introduction to the changing environment and technical issues that can affect working relationships and will highlight the collaborative relationships between library and information systems personnel within different organizational environments [academic, hospital system, and stand-alone hospital].

He is also the author of *High Performance Computing*. His research is the area of high performance parallel computing. Laurie Thompson is the director of the State University of New York Health Science Center Health Sciences Library at Syracuse, New York.

Doug Van Houweling is President and CEO of the University Corporation for Advanced Internet Development (UCAID). Prior to undertaking his responsibilities at UCAID, Professor Van Houweling was Dean for Academic Outreach and Vice Provost for Information and Technology at the University of Michigan.

Dr. Van Houweling received his undergraduate degree from Iowa State University and his Ph.D. in Government from Indiana University. He has consulted with numerous organizations and businesses and has written many articles on information technology, as well as on urban policies and the modeling of political processes.

He has been active in the Gopher and WWW communities since early 1992, and organized the first Gopher Workshop in August 1992. He began working with computer networks in 1979 as a consultant helping users of the Merit network. Previously he has contributed to a book on the VM/C MS operating system and to Computer Language magazine and the Internet Letter. He moderates the Usenet News group comp.infosystems.announce, and has presented at the Special Libraries Association's annual conferences. Along with Charles Severance, Wiggins hosts the television show Nothin' but the Net.



Directions to the Amway Grand Plaza Hotel

From the North:

- •US 131 South
- •Exit at Pearl Street (first exit after I-196 interchange)
- •Left on Pearl Street
- Continue on Pearl Street to hotel, which will be on the left immediately after crossing bridge over river (Pearl & Monroe)

From the South:

- •Take I-94 East or West to US 131 North
- Exit at Pearl Street
- •Right on Pearl Street
- •Continue on Pearl Street to hotel, which will be on the left immediately after crossing bridge over river (Pearl & Monroe)

From the Southwest:

- •I-196 East
- •Exit at US 131 South
- •Exit at next exit Pearl Street
- •Left on Pearl Street
- Continue on Pearl Street to hotel, which will be on the left immediately after crossing bridge over river

From the West:

- •I-96 East
- •Exit at US 131 South
- •Exit at 4th exit, Pearl Street (first exit after I-196 interchange)
- •Left on Pearl Street
- •Continue on Pearl Street to hotel, which will be on the left immediately after crossing bridge over river

From the East:

- •I96 West to I-196 (signs will indicate downtown Grand Rapids, Holland)
- •West on I-196 to Ottawa Avenue exit
- •Ottawa Avenue (one way) to first intersection, Michigan Street
- •Right on Michigan Streetimmediately get into left lane
- •Left on Monroe Avenue (next intersection)
- •Right on Pearl Street (second traffic signal)
- Continue on Pearl Street about a half block to hotel entrance, which will be on the right

From Kent County International Airport

- As you leave airport take right at first light (Patterson)
- •Take Patterson to 28th St and turn right
- •Take 28th St to I-96/196 West, enter on left
- •Continue on 196 to downtown Grand Rapids
- Take Ottawa exit, go to second light (Lyon) and turn right
- •Go to first light (Monroe) and turn left
- •Go to first light (Pearl) and turn right
- •Hotel sits on corner of Pearl & Monroe, main Entrance on Pearl (Pearl & Monroe)
