Big Rapids Hotel Group Makes \$25,000 Donation to Ferris

BIG RAPIDS - The new owners of the Holiday Inn Hotel and Conference Center in Big Rapids were welcomed to the community with open arms by Ferris State University, and some area business and community leaders during a luncheon at the facility on Tuesday, Feb. 19.

And representatives for the Big Rapids Hotel Group reciprocated with a \$25,000 donation to the university. The presented check was the first installment of five unrestricted gifts from BRHG. Jerry Scoby, vice president for Administration and Finance, accepted the check and expressed appreciation for the generous donation to the university.

Tuesday's luncheon, hosted by the university, was an opportunity to introduce Donald Schappacher, president and CEO of American Hospitality Management, Inc. and Fred Kindell, senior vice president of AHM, the parent company of Big Rapids Hotel Group.

Ferris' Board of Trustees in July approved an agreement for Cheboygan, Mich.-based AHM to purchase the 118-room Holiday Inn Hotel and Conference Center, owned by the university since 1990.

The Big Rapids property is located on Perry Street on the west edge of the Ferris campus and next to the university-owned Katke Golf Course.

AHM, formed in 1999 and based in Cheboygan, has 25 properties in nine states, including eight in Michigan. The company is a nationwide, award-winning, hospitality management group that services limited and full-service hotels, extended stay and resort properties.
