- Detroit Public Schools Counselors will be on campus Friday beginning in the Granger Center with a presentation, lunch in Rankin Center, and a presentation by the Biology department.
- Dawg Days will be held this weekend.
- The Veteran's Breakfast sponsored by the President will be held on November 11 at 7:30 a.m. in the Dome Room.
- The annual Cedar Point bus trip will take place this weekend with two buses secured.
- Dr. Scott Herron is partnering with the GEAR-UP program in Baldwin to do service learning projects concerning ecology. The Baldwin Public Schools are excited about this opportunity as their science scores are low and hopefully this will assist them. Gloria Lukusa-Barnett will be collaborating with Muskegon Public School in Career Exploration.
- Student Conduct reported that the Hall Directors are doing a great job in working with their students and supporting Student Conduct's philosophy. Kristen and Nancy will be attending the ASJA conference at Saginaw Valley.
- FSU DPS is working closer with the city and county in which Student Conduct is receiving more reports than before. Kristen also spoke to a FSUS class about academic misconduct.

- Career Services has 115 employers registered for the Job Fair next Thursday which is lower than last year. Anyone interested in assisting should contact Carrie Adams. Leroy indicated that students are lined up to use Career Services.
- The new Coordinator of Career Services is Angela Roman who will begin Ferris on October 8.
- Leroy Wright announced that applications for Team Leaders are now being accepted. The Orientation Leader applications will be available mid October. Dr. Burcham asked that the Communication Center be informed of these opportunities.
- The Admissions Office has a new website (meeting graphic standards) with information on where the recruiters are each day. The IPEDS federal report has been submitted; however, the State reports had technical difficulties in submission. The due date has been extended to October 6.
- Two former FBI agents, Steve Romano and Gene Rugala, will be on campus October 6-7. Everyone is invited to the presentations. They will return to campus November 3-4 to develop a Threat Assessment Team and will be placed on a retainer for a year.
- The Student Rec Center will be offering an adult learn to swim program. The WOW program is under way.
- The Financial Aid State and Federal reports are completed and need to be mailed in. Ferris received \$400,000 and only has to return \$500 in Nursing scholarships. We had overspent the work study budget by \$100. We are not allowed to ask for more funds if there is money left from the previous year. According to the Financial Aid regulations, we are in compliance since we offered activities on Constitution Day (activities were offered a whole week).
- Institutional Research and Testing is working on creating a Financial Aid satisfaction survey on the web.
- Interviews are being conducted today for the Traverse City recruiter position. The interviews for the Veteran's position will be conducted tomorrow.
- Birkam Health Center will be conducting a Flu Clinic next Tuesday and Wednesday.
 The National Depression Screening Day will be held next Friday. Many presentations are being made regarding emergency situations. Collaboration is being done with FSU-GR on training for emergency situations. A chronological list will be developed for this.
- The NCAA Choices Grant is in its third and final year which covers the Social Norming program.
