III. Approval of March 2, 1999 Minutes – Minutes were approved as written.

V. Committee Reports

Senate Governance Committee – Senator Heidemann – No report at this time.

University Curriculum Committee - Senator Lovsted distributed the UCC Senate Report dated April 6, 1999 that summarized proposals being addressed (See **Attachment B**) and proposed language changes for the UCC Manual in response to the Integrative Studies Proposal. **Senator Haneline** indicated that the first pending item on the UCC April 6, 1999 report should be **English Education Major Curriculum Clean up.**

Senate Elections Committee – Senator Ferdowsi stated that Senate Elections were held March 23 & 24, 1999. He thanked all those involved in making the election a success. **Attachment C** is a summary of balloting information.

VI. New Business

Doctor of Pharmacy Curriculum – Moved by Senator Thapa, with support from Senator Haneline, to accept the Doctor of Pharmacy Curriculum for first reading. Many Pharmacy faculty were on hand to answer questions. After a lengthy discussion, President Key stated that this proposal would come before the Senate for approval at its April 27, 1999 meeting.

UCC Manual Changes– Moved by Senator Lovsted, with support from Senator Papo, to accept the proposed UCC Manual changes **(Attachment D)** submitted. Motion passes unanimously.

VII. Old Business

Master of Education, Curriculum and Instruction – Moved by Senator Lovsted, with support from Senator Konrad to accept the proposal as presented. Motion passes unanimously.

New Option for Existing Masters of Education – Moved by Senator Lovsted, with support from Senator Ryan to accept the proposal as presented. Motion passes unanimously.

Academic Senate Charter – Motion by Senator Nagel, with support from Senator Abbasabadi, to accept the Senate Charter as revised. After a brief discussion, motion passes unanimously.

VIII. Announcements

Vice President Chapman - William Potter has accepted the position of Dean of the University College and will begin July 1, 1999. George Waldheim has accepted the Dean of Technology position. He will begin August 1, 1999. The search for Assistant Vice President continues, with selection being completed during the upcoming week. Interviews for Chancellor are completed. The Vice President's Office is working on a report for President Sederburg on Post Tenure Review. There were 94 reviews conducted.

Interim Vice President Avritt reviewed the materials and posters that are used for recruitment of FSU students. She responded to comments and suggestions from Senators and explained the rationale behind recruitment activities.

President Key reminded Senators that there would be a presentation to the Senate on Monday, April 12, 1999 at 7:00 p.m. in the Centennial Dining Room. President Sederberg, Dr. Chapman and Dr. Uniacke will present Unit Action Plans, budget information, and an update on FSU Grand Rapids. The last Senate meeting is on April 27, 1999. A new Executive Board will be elected at that meeting.
