

## DO'S AND DON'TS

## FOR CONSUMER HEALTH REFERENCE QUESTIONS\*

DO:

Avoid any implications of possessing medical training and knowledge

Help requesters define and formulate questions to ask of their health care providers

Assist persons understand what they have been told by health professionals

State that medical information can be rapidly outdated

Inform patrons that there is often a lack of consensus on many medical topics.

Suggest alternative sources of informationm on controversial topics to present a balanced perspective

Tell people that statistics and probabilities can be misleading and need expert interpretation

Refer patrons to relevant support organizations and health associations that can be of help

## DO NOT

Provide medical advice and interpretation

Offer an opinion as to diagnosis, treatment or prognosis

Recommend drugs or alternate drugs

Suggest the name of a specific practitioner

Identify alternative therapies in cases where traditional medicine has failed

Interject any moral judgement on sensitive issues such as abortion and living wills
