STATEMENT OF AIMS

Traditionally, MHSLA's emphasis has been in its educational conferences. In the past several years, this activity has been expanded to include union listing and interlibrary loan. I believe this to be a sign of strength and maturity for the Association.

In order to help the organization grow further, I would like to work through the committee structure to develop a true statewide resource-sharing network. The Interlibrary Loan Committee should work with DOCLINE implementation, collect annual ILL statistics and prepare workshops to be delivered in at least four parts of the state. The Union List Committee should address the problems of updating to keep the database current.

We need to look more carefully at our membership. The Association could be strengthened by drawing in more members from the academic and special health science library communities.

The business of the organization should be fully documented with written goals and objectives, committee charges and annual reports. Committees should be appointed well in advance so that they can spend a whole year working on their objectives.

Many opportunities lie ahead for MHSLA. With thoughtful planning, energetic implementation and careful follow-through, MHSLA can advance the goals of health science librarians in Michigan.
